1	The total number of sections of the school from class I to XII shall be restricted to 15, out of which the school can run not more than 02 sections in secondary classes i.e. 01 in class IX and 01 in class X and not more than 04 sections in senior secondary classes i.e. 02 in class XI and 02 in class XII, subject to the condition that the school shall not run more than 1/4 and 1/3 of the total sections running in the school at any point in time at the secondary level and senior secondary level, respectively. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of land and class rooms of greater than 500 sq ft dimension.
2	The school is directed to run at least 01 section each of bal-vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
3	The school shall conduct training of its teachers with CoE, Dehradun within 03 months and submit the compliance.
4	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per annexure – IX) on school's website at all time and the link of certificates should remain functional and submit an undertaking in this

5	As per the recommendation of NEP, the school shall ensure the participation of its students in the Structured Assessment for Analyzing Learning(SAFAL), an exam conducted by the Board every year. This exam, designed to assess and enhance students' learning, is a valuable initiative for their holistic development, as per the guidelines issued by the Board vide circular no: Acad-49/2024 dated 26 June 2024.
6	The school will ensure the Holistic Progress Card (HPC) is used for the foundational stage according to the guidelines issued by the Board via notification no. CBSE/Director (AcadAssessment)/2023 dated 27.12.2023.
7	The school shall submit an undertaking to upload all requisite information regarding students, teachers, and infrastructure details available in the school on the UDISE and OASIS Portals. The registration of the students in classes IX and XI shall be conditional on the school providing complete information on the UDISE and OASIS Portals.
8	The school shall ensure that all teachers undergo at least 50 hours of Continuous Professional Development (CPD) every year, vide notification no. 16/2021 dated 24.09.2021, out of which 25 hours should be from COE Dehradun.
9	Curtains are found installed in the Composite Science Lab which may poses fire hazard. Workstations are not developed properly with the fixtures such as Pipped Gas, sink with water supply. Acid and chemical are not stored in lock and key. The workstation in Biology and Composite science labs developed by the school in adjacent to the wall which is not appropriate to conduct the practical. Seating arrangement such as lab stools are not provided in the lab. School shall improve the lab in accordance with the SoP issued by the Board vide circular no. 11/2022 dated 04.10.2022 within 03 months and submit its compliance of SARAS portal.
10	Library is undersized. adequate furniture to accommodate 50 students at a time is not available. Separate reading area for the staff is not developed. Space for project and activities are not available in the library. School shall setup the library in a bigger room and improve the library in accordance with the SoP issued by the Board vide circular no. 11/2022 dated 04.10.2022 within 03 months and submit its compliance of SARAS portal.
11	The ramp constructed by the school for access of upper floor is steep and unsafe for use of students bound to use wheel chairs. Entrance of CwSN toilet is very narrow and proper grab bars are not installed in both side of the toilet. School shall install the grab bars and sliding door in CwSN Toilets and reconstruct the ramp with proper incline in accordance with the guidelines issued by the Board and as per the norms laid down in the RPwD Act, 2016 within 03 months and submit its compliance of SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye Laws-2018.
- 2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and
